This application shall be completed by an officer of the club seeking a license. This application and the proof of liquor liability insurance must be filed with the City Clerk. To qualify for a license, a club must have at least fifty (50) members, been in continuous existence for at least three (3) years, have an elected governing board and limit sales to members and bona fide guests only. The annual license fee is set by statute (M.S. 340A.408). Granting of a license by County or City is discretionary.
